Getting Help in The Courtroom

If you qualify, and need legal help on your day of court, you can talk to a lawyer (duty counsel) at the courthouse for free legal advice. Family duty counsel are paid for by LAO and are at every family law court on a first-come, first-served basis.

Sign up for an appointment upon arrival.

Duty counsel can:

- give you advice and information
- tell you about your rights and what you have to do
- tell you how the court process works
- in some cases, help you with your documents
- in some cases, represent you

Information and Referral Coordinators (IRCs) are available at designated times to help you understand your needs and to make referrals to appropriate services. IRCs can give you information about family mediation and other ways to solve your issues without going to court.
